

**Information on the processing of personal data in compliance with the provisions of current legislation  
on the protection of individuals with regard to the processing of personal data,  
as well as the free movement of such data.**

**European Regulation 2016/679 (GDPR)**

A. **Petazzi Costruzioni SRL**, intends to inform you about the modalities and the necessity of the processing of the following personal data:

- Identification data such as name, surname, telephone, e-mail

B. **Legal basis for processing.** The collection and subsequent processing of the data above will be for legitimate purposes only:

- to follow up on your contact request;

C. **Type of processing.**

- the processing will be carried out either manually or with the help of computer and telematics systems;
- the processing will be carried out by means of the operations or set of operations indicated in Article 4) of the 2016/679 EU Regulation;
- the processing does not involve automated decision-making processes;
- the treatment may involve profiling processes;
- the treatment will be carried out for statistical, commercial, promotional and marketing activities
- the personal data will not be transferred to operators outside the EU borders;
- the personal data may be communicated to the following operators within the European Union;
  - subjects who are providing services for the management of the information system and telecommunications networks (including e-mail);
  - subjects that carry out checks, audits and certification of the activities carried out by Petazzi Costruzioni SRL, also in the customers' interest;

Which have ensured compliance with the requirements of the 2016/679 European Regulation (GDPR).

D. **The retention period** of the data or the criteria used to establish this period is defined in relation to the current regulatory provisions.

The data sent to us by filling in the appropriate form are kept for the strictly necessary time to carry out the activities specified in point B. At the expiry date, the data will be deleted or anonymized, unless there are further purposes for the storage of the same.

E. **The exercisable rights.** You will be able to assert your rights as an interested party as expressed in the 2016/679 European Regulation (GDPR). In particular, the rights you can enforce are the following:

- Right to access personal data (see Article 15 GDPR);
- Updating, rectification of personal data (see Article 16 GDPR);
- Opposition to the processing of personal data (see Article 21 of the GDPR);
- Right to data portability (see Article 20 GDPR);
- Right to be forgotten / erased of personal data (see Article 17 GDPR);
- Right to restriction of processing (see Article 21 of the GDPR);
- Right to file a complaint with the supervisory authority (in case of violation of the rules)
